

# RECREATIONAL ACTIVITY RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

Please read and be certain you understand the implications of signing.

## Express Assumption of Risk Associated with Recreational Activities.

I, \_\_\_\_\_ do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with the recreational activity generally described as Airsoft, Airsofting use of Airsoft equipment, including the rental of equipment and transportation associated therewith in which I am about to engage. **Inherent Hazards and risks included are not limited to:**

1. Risk of Injury from the activity and equipment utilized is significant including the potential for permanent disability and death.
2. Possible equipment failure and/or malfunction of my own or others equipment.
3. This activity takes place outdoors and therefore includes risk associated with exposure to elements, excessive heat, hypothermia, impact of the body upon the water, injection of water into my body orifices, encountering objects either natural or man made, exposure to animals with the attendant risk of kicking, biting, shying away, running off or otherwise moving in an unanticipated manner causing injury and/or death.
4. My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, trails, or route location.
5. Attack by or encounter with insects, reptiles, and/or animals.
6. Accidents or illness occurring in remote places where there are not available medical facilities.
7. Fatigue, chill, and/or dizziness which may diminish my/our reaction time and increase risk of accident.

**\*I understand the description of these risks is not complete and that unknown or unanticipated risks may result in injury, illness, or death.**

## Release of Liability, Waiver of Claims and Indemnity Agreement

In Consideration for being permitted to participate in the activity(ies) described above and related activities, I hereby agree, acknowledge and appreciate that:

1. **I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH,** or loss or damage to person or property, **WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE**, the following names persons or entities, herein referred to as releasees.

This release shall be binding to the fullest extent permitted by law. If any provision of this release is found to be unenforceable, the remaining terms shall be enforceable.

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,

In consideration of participating in the sport of airsoft and use of airsoft equipment by ROUNDHOUSE PRODUCTIONS LLC. I represent that I understand the nature of this Activity, and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity. I acknowledge that I have read **"Roundhouse Production Rules and Regulations (10/5/05)"** attached hereto and agree to abide by each and every rule and regulation therein.

I fully understand that this Activity and use of airsoft equipment involves risks of serious bodily injury, including, but not necessarily limited to, permanent disability, fracture, eye injury including blindness, heart attack, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the releasees named below; and that there may be other risks either not known or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for physical injury or death, losses, costs, and damages I incur as a result of my participation in the Activity. I hereby consent and give permission for ROUNDHOUSE PRODUCTIONS to authorize emergency medical treatment it deems necessary in case of an accident while participating in a ROUNDHOUSE PRODUCTIONS event on property owned by the Redevelopment Agency of the CITY OF MARINA.
